4. Original Service Books with up to date entries and CCR of all the eligible SI(Optr.) with up to date remarks be furnished. If the SI(Optr.) is retired/expired/unwilling it should be intimated to this Hdqrs. immediately.
5. If anything adverse about the work and conduct punishment awarded against the SI(Optr.) reported between the period from submission of the nomination roll and sitting of the CSB meeting the same be brought to the notice of this Hdqrs. immediately.
