Sub:- Timely submission of pension papers to Accountant General (A&E),
Odisha.

Sir,

I am directed to say that modalities prescribed for payment of pension and other pensionary benefits to a retired / retiring Government servant are time bound and even the Officials who are to take steps are specified.

Ruel-62 (2) (i) of OCS (Pension) Rules, 1992 provides that "The Appointing Authority shall sanction the pension in Part-II of Form-7 and intimate the same to the Accountant General (A&E), Odisha in Form-9 not later than four months before the date of retirement of Government servant."

Deputy Accountant General, Office of the Principal Accountant General, Odisha has brought to the notice of self in a meeting held on 21.08.2013 that pension papers of a retiring Government servant are not received in the Office of Accountant General (A&E), Odisha as per above provision rather it is received even after 2 to 3 years or even later after the date of retirement of Government servants. As a result it causes inconvenience not only to the retired / retiring Government servants, but also to Accountant General (A&E) Office, Odisha to process the same.

In the circumstances cited above, I am therefore to request you kindly follow the time schedule prescribed in the rule and submit the pension papers of the retiring Government servants to Accountant General (A&E), Odisha / Controller of Accounts, Odisha before 4 months of retirement of a Government Servant and suitable instructions may be issued to all Pension Sanctioning Authorities under your administrative control accordingly, to follow the rule meticulously.
