Formation of Security Wing in State Special Branch under the Intelligence Organisation of Orissa Police to meet the threat of organized terrorist groups to VIPs and vital installations.

Sir.

I am directed to convey the sanction of the Governor for creation of a "Security Wing" in State Special Branch under the Intelligence Organisation of Orissa Police comprising of 356 personnel in various grades and ranks to meet the threat of organized terrorist groups to VIPs and vital installations. Of the 356 posts, sanction of Governor for creation of 193 (one hundred ninety three) new posts is conveyed for the Security Wing listed below in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by Government from time to time except in the case of Assistant Driver and Follower Orderly whose appointments shall be on contractual and consolidated remuneration basis. These 193 posts are sanctioned from the dates those are actually filled up.

- 5. The Security Wing of the State Special Branch will be headed by a Police Officer of the rank of Superintendent of Police for which new post is created. The S.P., Security will be working under the direction and supervision of Director, Intelligence who will be the Director of the Security Wing also. The Director, Intelligence may authorize a D.I.G. of Police/I.G. of Police (Intelligence) to supervise the work of Security Wing.
- 6. The headquarters of the Security Wing of the State Special Branch will be at Bhubaneswar.
- 7. There will be no direct recruitment to the posts sanctioned for the Security Wing. All the persons shall be brought in from various cadres or Units of Police Department or in suitable cases on deputation basis from outside. The vacancies caused in various Police Cadres and Units because of posting of persons to the Security Wing shall be filled up by observing the recruitment rules applicable for filling up those posts in the prescribed manner. The persons being posted in Security Wing must have been working in the same scale of pay.

- 8. There shall be no fixed tenure for posting in security wing. Anybody posted to Security Wing may be reverted to his cadres or unit at any time without any notice. The Director, Intelligence will identify from time to time the suitable persons for their posting to Security Wing and send proposals accordingly to the Director General of Police for decision.
- 9. All the persons posted to the Security Wing (exclusively) will be entitled to a Security Allowance @ 15% of their Basic Pay and Dearness Pay in addition to other allowances to which they are entitled in their parent rank.
- 10. The executive personnel shall be entitled to get 'Mufti' clothing allowances @ Rs.675/- per annum from the rank of Inspector to A.S.I. and @ Rs.1000/- per annum from Havildar to Constable/Sepoys. The Officers/ men performing P.S.O. duties shall be entitled to get Safari Suit Allowance @ Rs.3,000/- per annum.
- 11. The Officers/ men posted to Security Wing shall be entitled to avail rent free accommodation. Those who may not be occupying Government accommodation shall be paid House Rent Allowance as admissible to the post by the Government.
- 12. The Charter of duties of the Security Wing shall be governed by the instructions laid down in Special Branch Manual, Chapter-III to VI which has been approved by the Government vide Home Department Letter No.1676/C, dated 15.4.2005. The detailed duty distribution relating to various Units of the Security Wing e.g. proximity security to Chief Minister, Assembly Security, VIP Security, Technical Wing, Bomb Disposal Squad, Administrative Wing will be made by the Director, Intelligence with the approval of the Director General of Police.
