OFFICE ORDER No. 384 /Exe Date: 10.04.2013


Having been selected by the Spl. Central Selection Board held at State Police Hdqrs. on 2.4.2013 and in pursuance to Govt. of Odisha, Home Deptt. Notification No.11400/D&A dt. 28.02.2009, Const./ 1014 Gopal Krushna Sahoo of Cuttack UPD who has passed the written examination of Constables to undergo the ASI's course of training held in the year 2002 is allowed to officiate as ASI of Police in Police Commissionerate pending passing the final examination of ASI's Course of training. He will assume the higher charge of Officiating ASI of Police from the date of his joining. He will be deputed to undergo ASI's course of training for a period of four months comprising of one month institutional basic training at designated training institution and 3 months practical training in the Police Station and shall be required to pass the final examination to be conducted simultaneously in due course.

Pending passing the final training examination, he will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr. P.C. during the officiating period as Officiating ASI of Police. On the basis of the results of the final examination, his seniority inter-se will be determined according to the marks obtained by him in the final examination. His seniority in the rank of A.S.I. shall be reckoned from the date of passing the final examination in A.S.I's. course of training. If he fails in the final examination, he will be allowed two more chances to clear the failed subject(s). In the event of failure to clear the failed subject(s) in two successive attempts, he shall be reverted to the substantive rank i.e. the rank held immediately prior to his officiating as ASI. The annual increments shall not be allowed unless and until the aforesaid examination is passed by the officiating A.S.I.

His posting has been decided by the "Police Establishment Board" in accordance with Home Department Notification No. 18407/D&A dt. 6.4.2007.
