In order to fill up the vacancies in the rank of SI of Police for the year 2013 by way of promotion, the Nomination Rolls of the eligible ASI of Police as on 01.01.2013 in the prescribed proforma (enclosed) along with Service Books and CCR may please be furnished to this Hdqrs. by 29.06.2013 positively through the respective Range Office in the following manner for holding CSB Meeting. In this connection, the seniority list of eligible ASIs posted in different Districts/Establishments is enclosed for reference.

1. Nomination Roll in six copies of all the ASIs.
2. Rewards/punishments (Major/Minor) earned by the ASIs during last five years as on 31.12.2012 and prior to that may be properly calculated and reflected in appropriate columns of the Nomination Rolls along with up to date informations till date and the same may be duly flagged in the Service Books and a copy of chart showing rewards/punishments be kept in the first page of the Service Book for reference.
3. Details of Departmental proceedings/Vigilance/Criminal/HRPC related cases along with other allegations if any pending/contemplated against any of the ASIs be properly reflected in appropriate column of the Nomination Rolls and copy of charge there of be furnished.
4. Original Service Book with up to date entries and CCR with up to date remarks of all eligible ASIs (properly flagged) be furnished. Copy of Caste Certificate in respect of SC/ST candidates duly attested must be made

available in the Service Book for reference and the category of the candidate should be specifically mentioned in the Nomination Rolls against his name.

5. If the ASI has retired / expired / transferred / unwilling for promotion / promoted, the same should be intimated to this Hdqrs. immediately.
6. A certificate of physical fitness to undergo DCSI's course of training at BPSPA, BBSR. issued from concerned CDMo in Form No.39 of Schedule-IX should be furnished in respect of each ASI along with the Nomination Rolls as required under PMR 659 (C) in the Medical Fitness Certificate it should be specifically mentioned that the nominee is physical fit to undergo DCSI's course of training.
7. If there is anything adverse about work/conduct punishment awarded against the ASI comes to notice of the concerned authorities between the periods from submission of Nomination Rolls and sitting of the CSB meeting, the same should be brought to the notice of this Hdqrs. immediately.
8. A certificate to the effect be furnished that all informations furnished are true/correct to the best of your knowledge and no senior to the nominees is excluded.
9. In the event the ASI is transferred to Other District/Establishment in the meantime, the concerned District/Estt. may furnish the Nomination Rolls to this Hdqrs. through their Range Offices.
10. If senior to the nominee is omitted in the list his Nomination Rolls may also be furnished along with the other ASIs indicating his date of birth and date of passing ASI course of training.
11. The Nomination Rolls without up to date CCR will not be entertained at this Hdqrs. under any circumstances. All columns of the Nomination Rolls should be filled in correctly and nothing left blank.
12. The name of the ASI may be mentioned in each page of the nomination Roll.
